1. Introduction:-

IJIRA is a premium research organization linked to Ministry of Textiles, Govt. of India, engaged in R&D activities with the objective of rendering scientific and technical assistance to the jute industries.

2. Scope of work:-

There is a requirement for pest control activity at IJIRA. The entire premises need to be well treated for the following:-

- Cockroaches
- Ants-Red and Black
- Snake

- Silver fish & Firebrats (for IJIRA Library)
- Rats
- Mosquito

Regular vigilance of the area with proper guidance has to be provided by a representative of the company visiting IJIRA after every fortnight. Proper supply of right chemicals has to be ensured. The service has to be provided once in a week (preferably Friday after 4.00 pm).

3. Area of work:-

IJIRA premises: Main Building (ground floor to 1st Floor) and Annex Building (ground floor to fourth floor) along with the outside open area.

4. Cost break-up:-

- Quality of the key materials to be used needs to be specified.
- Total cost for the service including GST (monthly).
